Important Points of "Economic Survey year 2024-25", Gross State Domestic Product (GSDP) Advance estimate for 2024-25

During the Assembly Budget Session, the "Economic Survey Year 2024-25" of Chhattisgarh was presented. This publication highlights the state's quick estimate of Gross State Domestic Product (GSDP) for 2023-24 and the advance estimate for 2024-25, as outlined in Tables 1 and 2. Additionally, it provides a critical analysis of economic progress, the socio-economic situation, key influencing factors, and various state government schemes.

1. Gross State Domestic Product (GSDP) Prospects of Progress in the Year 2024-25

1.1 At constant prices (base year 2011-12), The Advance Estimates of Gross State Domestic Product (GSDP) for the year 2024-25 is projected to increase from Rs. 3,06,712 crore in 2023-24 to Rs. 3,29,752 crore, reflecting a growth of 7.51% compared to the previous year.

The Agriculture and allied sector is expected to rise from Rs. 48,987 crore in 2023-24 to Rs. 51,621 crore in 2024-25, marking an increase of 5.38%. Similarly, the Industry sector is estimated to grow from Rs. 1,37,649 crore to Rs. 1,47,172 crore in 2024-25, showing a growth rate of 6.92 %. The Services sector is projected to expand from Rs. 99,925 crore in 2023-24 to Rs. 1,08,461 crore in 2024-25, reflecting an increase of 8.54%.

1.2 At Current prices:- As per advance estimates, the Gross State Domestic Product (GSDP at Market Prices) for the year 2024-25 is projected to increase from Rs. 5,12,107 crore in 2023-24 to Rs. 5,67,880 crore, reflecting a growth of 10.89% compared to the previous year.

The Agriculture and allied sector is expected to rise from Rs. 97,958 crore in 2023-24 to Rs. 1,07,038 crore in 2024-25, marking an increase of 9.27%. Similarly, the Industry sector is estimated to grow from Rs. 2,12,306 crore to Rs. 2,31,871 crore in 2024-25, showing a growth rate of 9.22%. The Services sector is projected to expand from Rs. 1,71,335 crore in 2023-24 to Rs. 1,94,346 crore in 2024-25, reflecting an increase of 13.43%.

2. Gross State Domestic Product (GSDP) Prospects of Progress in the Year 2023-24 (Quick)


- 2.1 At constant prices (base year 2011-12):- According to the quick estimate of the state's Gross State Domestic Product (GSDP) at constant prices there was a 7.31% increase in 2023-24 compared to 2022-23. This growth includes a 3.03% rise in the Agriculture and allied sectors (comprising agriculture, animal husbandry, fisheries, and forestry), a 4.87% increase in the Industry sector (including construction, manufacturing, mining and quarrying, electricity, gas, and water supply), and a 10.43% growth in the Service sector.
- **2.2 At Current prices**:- According to the quick estimate of the state's Gross Domestic Product (GSDP) at current prices, 11.60% increase is estimated in 2023-24 compared to 2022-23. This includes an 8.71% rise in the Agriculture and allied sectors (comprising agriculture, animal husbandry, fisheries, and forestry), a 10.16% increase in the Industry sector (including construction, manufacturing, mining and quarrying, electricity, gas, and water supply), and a 13.57% growth in the Service sector.








Sector-wise Percentage Growth Compared to the Previous Year at Constant Prices (2011-12





Sector-wise Contribution Percentage to Gross Domestic Product (at Constant Prices 2011-12) for the Year 2024-25 (Advanced Estimates)
















Sector -wise Percentage Growth Compared to the Previous Year at Current Prices






Sector-wise Contribution Percentage to Gross Domestic Product (at Current Prices) for the Year 2024-25 (Advance Estimates)"





3. Per Capita Income (Net State Domestic Product per capita at current prices):- Per Capita Income is estimated to increase from Rs. 1,48,922 (one lakh forty-eight thousand nine hundred twenty-two) as per the quick estimates for 2023-24 to Rs. 1,62,870 (one lakh sixty-two thousand eight hundred seventy) in the advance estimates for 2024-25, it's reflecting a 9.37% increase compared to the previous year.
